#### **Project Background: Include3**

- EU call for more research on sheltered employment
- Research area: Transition of sheltered jobs for people with cognitive impairment into the regular labor market.
- Need:
  - Vocational training and employment in workshops for people with disabilities
  - More transitions to the primary labor market







#### **Objectives**

1. Inclusion and diversity in all fields of education, training, youth and sports:

Achieving such personalised alignment of workshop VET(: vocational education and training) with labour market opportunities will open pathways to sustainable employment and decent work in the open labour market instead of segregated sheltered employment. This aim will be supported by the involvement of people with intellectual disabilities in the development of resources and the curriculum. The curriculum itself provides for a fully inclusive process in which people with intellectual disabilities, CGC(:career guidance and counselling) and VET professionals and employers collaborate on equal terms.





#### **Objectives**

#### 2. Adapting vocational education and training to labour market needs:

The materials, recourses and tools, and above all the method developed are geared to use an inclusive CGC process to align the needs of the local labour market and the outcomes of vocational training in sheltered workshops by orientating the latter towards the former while putting the learning needs, capabilities and aspiration of people with intellectual disabilities at the centre.

All the project's products are designed to support professionals, employers and people with intellectual disabilities to achieve a better fit between VET and available work.





#### **Definitions**

# Sheltered Workshops

Sheltered workshops are spaces for people with disabilities with the aim of providing vocational training to facilitate a transition into (supported, if necessary) employment in the regular labour market.





#### **Definitions**

### Sheltered Employment

Sheltered employment refers to a work environment or program specifically designed to provide employment opportunities for individuals with disabilities or other barriers to traditional employment. It offers a protected and supportive setting where individuals can engage in meaningful work tasks suited to their abilities and receive appropriate support.





#### **Definitions**

### Person with Disabilities

- According to Art. 1 UN CRPD, persons with
  disabilities include people who have long-term
  physical, mental, intellectual or sensory
  impairments which, in interaction with various
  barriers, may prevent them from participating fully,
  effectively and on an equal basis with others in
  society
- Abilities in the cognitive, psychomotor and intellectual areas are counted among the mental abilities
- A low intelligence quotient can be an indication of the disturbance of mental abilities and consequently of an intellectual disability

#### 2. Building on good practice in Europe

A praxis-oriented report on good practices will present the results of the collection and evaluation of good practice and draw conclusions with regard to the role of centring processes on the needs and aspirations of people with intellectual disabilities; and will elaborate on the perspectives for harmonising sheltered VET and labour market needs through inclusive counselling processes.







#### 3. Inclusive Development of Guidelines for Practice

Six focus groups in three countries (in each of the three countries a focus group A with at least five sheltered-workshop participants with intellectual disabilities, focus group B with at least three participants from group A, three employer and four inclusion experts, at least two of which have VET responsibilities in a sheltered workshop. Focus groups will be moderated and observed by two members of the project teams.







#### 4. Curriculum

A curriculum for collaborative inclusive learning the Include³ method that will equip CGC professionals with all necessary skills and capabilites to organise inclusive counselling that connects sheltered VET and the labour market. The curriculum will cross-reference products from WP 2 and WP 3. Additional material will be developed as necessary to support the learning process.







#### 5. Interactive web portal and digital infrastructure

To make the project results available, accessible and usable particularly for people with intellectual disabilities. By providing resources and information in such a way we ensure that not only professionals but also people with disabilities themselves can use them to actively shape their vocational training and their future careers.
